#### PURPOSE PERMIT APPLICATION

The Flora and Fauna Study, with offset planting provisions, was forwarded to the Department of Environment and Conservation (DEC) on Wednesday 14 February 2007. The DEC was not entirely satisfied with the report and required additional information pertaining to some vegetation varieties and offset planting. This information has now been provided to them and the report was to be presented to the Chief Executive Officer on Friday 9 March 2007 for signing off.

#### STRATHERNE/PARSONS ROADS INTERSECTION

The surveyor (Peter Gow) has completed marking the centre line and levels at this intersection. Works are ready to commence as soon as approval has been obtained from the Department of Environment and Conservation in relation to the purpose permit application.

#### Background

Council has received an application for Planning Consent from Mr. Nicholas (the applicant) for the construction of a 135m2, 2.6 metre high Colorbond outbuilding on Lot 293 Colin Street, Cuballing (the subject property). The proposal is to build the shed only seven (7) metres from the boundary making it very noticeable from the road.

The applicant has indicated that the outbuilding is to be used to garage a new school bus to protect it from the heat and rain (as per the requirements for the school bus contract) and the location requested is for security and the minimum removal of established trees.

#### Comment

The subject land is zoned Rural Residential under the Shire of Cuballing's Town Planning Scheme No.2 (Local Planning Policy - Outbuildings).

#### **Oversized Outbuilding**

Council's Town Planning Scheme No. 2 Policy (Local Planning Policy Outbuildings) states that in a Rural Townsite and Rural Residential zones of the Shire where the lot size is over 1500m2 or on a General Agricultural zoned lots with an area of 2 ha or less:

(ii) Colorbond construction, where the total outbuilding does not exceed 120m2 in total floor area;

Any application for planning approval, which does not comply with the above, shall be referred to Council for consideration.

Council's Town Planning Scheme No. 2 Development Table indicates that sets backs for the Rural Residential Zone is to be determined by Council if it is not listed in the schedule of which, in this case, it is not.

Although there is no policy offering guidance to Council staff, each application will be assessed on its merits.

The shed will be more noticeable if it is built only seven (7) metres off the boundary of Colin Street and even more noticeable being 15m2 larger and 700mm higher than the requirements under the Outbuilding Policy. Furthermore, the boundary setback of the shed would be approximately 20 meters in front of the existing house.

For comparison with the Rural Townsite Zone under the Town Planning Scheme No 2 the set backs are fifteen (15) metres.

As a rule of thumb, Council Staff have been assessing similar projects under the Residential Design Codes (R2) of a twenty metre set back.

#### **CHIEF EXECUTIVE OFFICERS RECOMMENDATION**

That Council resolves to approve the construction of the 9m wide and 15m deep and 3.7m high to eaves, 135 m<sup>2</sup>outbuilding on Lot 293 Colin Street, Cuballing subject to the following conditions:

- The issue of an approved building license for the construction of the outbuilding;
- The outbuilding to be sited with a twenty (20) metre setback from Colin Street and not the seven (7m) setback as requested in the proposal from Mr Nicholas; and
- The outbuilding hereby permitted shall be only used for the purpose of either garaging the new school bus or incidental residential use of the property and shall not be used for any habitable or other purposes.

#### Background

Following notice sent out to residents of the Shire on 30 January 2007, on the future operations and management of the Cuballing Refuse Site, 10 responses were received by the submission date 9 March 2007.

#### Comment

The 10 responses varied within their context from total support of the whole management concept to varying degrees of support depending upon cost structure, opening days/times, possible introduction of refuse collection service, necessity of manager being in attendance during opening times, and various other comments. Copies of the responses have been circulated with the Council meeting agenda.

Now that Council has made an initial commitment to reviewing and improving the operation and management of the refuse site, staff consider it imperative that the process be followed through. Restricting the operating hours and manning the site when opened will control the dumping of refuse and ensure best practice procedures are introduced, particularly for recycling, reducing the amount of rubbish at the tip face and reducing wind blown litter around the site.

Further consideration now needs to be given to the following issues:

- Appointing a Refuse site manager;
- Office/ablution facility;
- Provision of power/generator and water;
- Fencing of the site (costs included on 2006/2007 budget); and
- Introduction of tipping fees. It is recommended that until such time as a refuse collection service is introduced residents of the Shire be provided with a tip pass for domestic refuse, a small fee be introduced for local commercial refuse, and more exorbitant fees be considered for non Shire waste (both domestic and commercial).

Determining the actual operating costs to introduce the above will be difficult to ascertain until Council has some indication as to what hourly rate a site manager will be asking for. Therefore staff could advertise seeking expressions of interest from suitable persons to help potentially fill the position and to enable a budget be prepared. The Shire of Williams has recently introduced a similar management structure at their Williams Refuse Site and it may be worthwhile Councillors and staff undertaking an inspection of that site to gain an understanding of how it is operating and some useful tips on the positives and negatives of the introduction process.

#### Background

At various Council meetings between 17 September 1992 and 17 November 1994, Council granted planning approval for the abovementioned kennels to be established in Popanyinning. Unfortunately, whilst Council could give planning approval under the provisions of the Shire of Cuballing Town Planning Scheme No 1, it did not have the authority to issue a kennel licence under the provisions of the Dog Act 1976 as a Dogs Local Law had not been adopted.

#### Comment

The Dog Act 1976, sections 26 & 27 refer to the keeping of dogs and licensing approved kennel establishments. Both sections state that the provisions are pursuant to the local government having adopted a suitable Dogs Local Law.

Given that Council has already granted planning approval it is now possible to issue a kennel licence under the provisions of the Dog Act 1976 and Shire of Cuballing Dogs Local Law 2004. No special advertising requirements apply.

A letter of application and application form in the prescribed format, in accordance with Schedule 1 of the Shire of Cuballing Dogs Local Law 2004, has been provided by Mrs Edwards.

#### **CHIEF EXECUTIVE OFFICERS RECOMMENDATION**

In accordance with the Dog Act 1976, sections 26 & 27, and the Shire of Cuballing Dogs Local Law 2004, a kennel licence be issued to M & S Edwards for the kennels operating at 1 (lot 136) Lord Street, Popanyinning.

#### Background

Correspondence advising that the WAPC has refused the above planning application.

#### Comment

This application was first presented to Council at its Ordinary meeting held on Thursday 16 February 2006. At the meeting Council resolved: "That the Western Australian Planning Commission be advised:

- That Council is prepared to support the subdivision application on the proviso that the portion of Lot 131 on the northern side of Bunmulling Road, and 0.463ha in size (which is smaller than the permitted minimum lot size without a reticulated water supply in accordance with TPS No 2 clause 5.12.6), is ceded to the Crown at no cost and incorporated into Reserve 11342 (Lot 126); and
- That an Environmental Impact study be undertaken because of the low-lying nature of the land."

Following the above resolution, and in their deliberations on the matter, the WAPC deferred a final decision on the application until 29 December 2006, and requested the proponents to provide a drainage management plan to the satisfaction of the Shire of Cuballing by this date.

Council staff and the Hotham Catchment Group Natural Resource Management Officer (NRMO) held separate meetings with Mrs Gray to assist and advise, where possible, with the drainage issue. On both occasions she was advised that Council staff and the NRMO did not have the expertise to prepare a plan for them and that they should contact the Department of Environment and Conservation and/or the Department of Agriculture. This does not appear to have happened and has resulted in the WAPC refusing the application.

#### Background

Correspondence from the owners Popanyinning General Store (S & J Maughan) seeking planning approval to operate a food caravan as a fast food outlet on the above lot which neighbours the Popanyinning General Store.

#### Comment

The proposal is for the food van to be located on the property to the northern side of the Store. The land is generally vacant but does contain a gas bottle enclosure/ramp at the rear. The food van is to be placed about 17 metres in front (or to the east) of the gas bottles and about 7 metres from the property boundary bordering onto Francis Street.

A Fast Food Outlet is classified as an "A" use in the zoning table of the Shire of Cuballing Town Planning Scheme No 2. This means that the use is not permitted unless Council has exercised its discretion by granting planning approval after giving special notice in accordance with clause 9.4 of the Scheme.

Clause 9.4.3 outlines the advertising requirements as indicated below:

The local government may give notice or require the applicant to give notice of an application for planning approval in one or more of the following ways

- (a) notice of the proposed use or development served on nearby owners and occupiers who, in the opinion of the local government, are likely to be affected by the granting of planning approval, stating that submissions may be made to the local government by a specified date being not less than 14 days from the day the notice is served;
- (b) notice of the proposed use or development published in a newspaper circulating in the Scheme area stating that submissions may be made to the local government by a specified day being not less than 14 days from the day the notice is published;
- (c) a sign or signs displaying notice of the proposed use or development to be erected in a conspicuous position on the land for a period of not less than 14 days from the day the notice is erected.

Sub clauses "a" and "c" of the above have been fulfilled. Notices (Schedule Eight of the Shire of Cuballing Town Planning Scheme No 2) have been served on neighbouring property owners and a sign (displaying Schedule Eight Notice) has been erected at the property. The Schedule Eight Notice provides full details of the proposal and advises that comments on the proposal may be submitted to Council on or before the 14 March 2007.

At the time of preparing this report no submissions have been received at the Shire office, however it is believed that the Popanyinning General Store has received some letters of support for the proposal and these will be provided to Council on 14 March 2007.

The proposal as presented has merit and would provide an additional service to the community of Popanyinning. Whilst the applicants haven't purchased a food caravan at this time they have been discussing the matter with Councils Environmental Health Officer/Building Surveyor and certainly appear keen to meet all health requirements. Any submissions received to the proposal will be tabled at the Council meeting for consideration.

The Chief Executive Officer informed Council that two letters have been received, and a petition with about 79 signatures, supporting the proposal. No submissions and/or correspondence has been received opposing the application.
