Background

Regional and Local Community Infrastructure Program

Under the recently announced Regional and Local Community Infrastructure Program (RLCIP) one-off funding totalling \$250m will be provided to local governments throughout Australia in 2008/2009 to help stimulate additional growth and economic activity as part of the Australian Governments contribution to address the global economic crisis. The allocation to the Shire of Cuballing is \$100,000.

A letter of offer and request for details of projects is being prepared and will sent to all Councils. Councils will have until 30 January 2009 to return the documentation advising of the identified projects, that they are ready to proceed and are additional to current operating budgets. Funding will be released soon thereafter.

The RLCIP funding can be allocated to:

- social and cultural infrastructure (eg art spaces, gardens);
- recreational facilities (eg swimming pools, sports stadiums);
- tourism infrastructure (eg walkways, tourism information centres);
- children, youth and seniors facilities (eg playgroup centres, senior citizens' centres);
- access facilities (eg boat ramps, footbridges); and
- environmental initiatives (eg drain and sewerage upgrades, recycling plants).

The Funding cannot be used for activities such as ongoing costs (eg operational costs and maintenance); transport infrastructure, such as roads; or related infrastructure covered by the Roads to Recovery or Black Spots programs.

Advice from the WA Local Government Association is that the funding should be used on new capital type programs or it could have an adverse effect on future Local Government Grants Commission allocations.

Royalties to the Regions Program

On Tuesday 16 December 2008, at a forum at the University of WA, the State Nationals Leader, and the Minister for Regional Development, Brendon Grylls, announced the Royalties to the Regions Funding Program. Under this Program grant funds totalling more than \$97m (in 2008/2009) will be paid to country local governments to enable critical infrastructure projects to be carried out. The funding program is set to run over a four year period.

The Shire of Cuballing has been allocated \$572,416 in 2008/2009, however full details of the RtR program are still yet to be received and therefore it is not known what criteria projects will have to meet to be compliant with the funding guidelines.

Comment

Council staff prepared a comprehensive list of likely projects, including works and costings, for Council consideration that fit within the guidelines for the RLCIP funding and are almost certainly expected to meet the criteria for the RtR program. Details of the projects were tabled at the Council meeting.

Whilst there is still some time for consideration for projects under the State Royalties to the Regions funding, Council needs to inform the Federal Government by no later than 30 January 2009, of projects to be carried out under the Regional and Local Community Infrastructure Program.

Councillors were requested to give further consideration for possible projects to be funded under the RtR program and the matter will be represented to the February 2009 Meeting of Council.

Background

The proprietors of the Cuballing Tavern, Brian & Donna Harvison, are applying to the Department of Racing, Gaming & Liquor (DRGL) to establish a "Breakout Smoking Area", including consumption of food and liquor, on the footpath area at the front of the Cuballing Tavern under the verandha.

The DRGL advised that they are prepared to support the Taverns application, however the Tavern owners need approval from Council in the first instance as the footpath area is part of the Alton Street road reserve and as such is under the care and control of the Shire of Cuballing.

As the Tavern would ideally like to have the extended permit in place prior to the oncoming Christmas/New Year Period, the Chief Executive Officer (CEO) forwarded an email to Councillors on 26 November 2008, seeking Councillor comment and feedback on the proposal. Six of seven Councillors responded supporting the proposal, one Councillor commented on the liability insurance aspect, and this has been investigated by the CEO.

As the area in question is an area of Council responsibility the liability issue will always remain, as a person/body corporate cannot transfer its liability responsibility onto another party. However in consultation with Councils insurers the Tavern has been requested to obtain a policy of insurance in the names of both the Shire of Cuballing and the Cuballing Tavern indemnifying the Shire in respect of any injury to any person or any damage to the property

which may occur in connection with the use of the Shire property by the Tavern. This has been included as a clause in the Trading in Public Places Permit which has been prepared for the purpose of the proposed activity.

Comment

In pursuing this matter and preparing the Trading in Public Places Permit, the CEO contacted the Shire of Gingin to obtain advice and guidance on the proposal. The Shire of Gingin supported a similar proposal by the Gingin Hotel in May 2007, and the Breakout Area has been functioning well. The CEO also had discussions with relevant persons in the DRGL to ascertain the processes and guidelines to follow with the application.

Following the response from Councillors and seeking the aforementioned advice, the CEO responded to the owners of the Cuballing Tavern on 1 December 2008, as follows:

With reference to your recent letter and our subsequent discussions, I hereby advise that the Shire of Cuballing supports your application to the Department of Racing, Gaming & Liquor to establish a "Breakout Smoking Area", including consumption of food and liquor, on the footpath area at the front of the Cuballing Tavern.

Please find herewith copy of Trading in Public Places Permit that has been prepared by Council and will be issued when final approval has been received from the Department of Racing, Gaming & Liquor, cost of permit will be \$100.

Background

Draft 4 of the Strategic Waste Management Plan, prepared on behalf of the Wagin Group by Bowman & Associates, was advertised for public consultation and has now been presented to the Department of Environment and Conservation for final endorsement.

The draft plan includes various recommendations for the 12 participating Councils. Two of the recommendations for the Shire of Cuballing are introducing a kerbside collection service for both landfill and recycling products, and consideration for establishing a central landfill site at Yornaning and closing of the Cuballing and Popanyinning sites.

Comment

In relation to these matters Council has been discussing (informally) for some time the benefit of a centrally located managed landfill site as opposed to expected higher costs to have two managed landfill sites at Cuballing and Popanyinning.

Therefore it is being proposed the following matters be considered by Council to enable staff to gain a clear understanding of where the Shire wants to be in terms of waste management in the future, most probably commencing in the 2010/2011 Financial Year:

- Engage the services of consultant (possibly Bowman & Assoc) to investigate suitability of Yornaning West site for future refuse site (landfill and recycling);
- If Yornaning West site is suitable and approved by the DEC, consultant to prepare management/business plan and post closure plan for the site:
- If Yornaning West site is approved, the Cuballing and Popanyinning sites to be discontinued in their current format;
- Introduce kerbside collection services in Cuballing and Popanyinning townsites for both landfill and recycling products;
- 240L bins (2) be provided to each household within the townsites by Council as one-off arrangement, to be the property of the household. Lost or damaged bins to be replaced/repaired by the property owner;

- Yornaning West site be managed by contract and opened on restricted basis as per the Cuballing site presently;
- Waste Contractor to be responsible for and to introduce as many recycling activities as possible, including: paper, cardboard, plastics, aluminium, tin, steel, batteries and electronic waste.

Further to the above, the gravel pit site on Yornaning West Road that has been identified as possible land fill site is in the process of being excised from existing water catchment reserve and being vested with the Shire of Cuballing for purpose of gravel. This change, which has been in process for about three years, is now proceeding and it is anticipated the new Management Order will be issued to the Shire of Cuballing early in the New Year (2009).

Once Council has control of the portion of reserve for gravel, actions could commence to include the purpose of "Waste Management and Landfill Site" if deemed suitable by the waste management consultant.

CHIEF EXECUTIVE OFFICERS RECOMMENDATION

That Council engages the services of Waste Management Consultant to:

- Investigate suitable centrally located waste management and landfill site within the Shire, possibly in the Yornaning area; and
- If suitable site is identified then undertake approvals process with the Department of Environment and Conservation and Environmental Protection Authority under the Environmental Protection Act 1986.

Background

In early 2007, Council worked with the Town Planning Consultant, Mr Trevor Moran, to prepare a number of addendums to the Shire of Cuballing Local Planning Strategy.

In April 2007, Council resolved to approve the various addendums to the Local Planning Strategy and forward them to the Western Australian Planning Commission (WAPC) for comment and endorsement.

Advice has now been received that the WAPC has certified the amendments to the local planning strategy, subject to a schedule of modifications being incorporated, and that the amendment should be advertised for a minimum period of three weeks in accordance with the provisions of the Town Planning Regulations 1967.

Comment

The various amendments to the Local Planning Strategy have basically been prepared to identify areas within the Shire to which pressures of growth, both residential and business, can be directed and/or accommodated in the future. A summary of the proposals for consideration follows:

Cuballing:

- 1. The consolidation of the town centre (increased densities dependent upon provision of adequate effluent treatment systems).
- 2. Rural Residential development to the north and Rural Townsite and Rural Residential development to the south of the town (subject to land capability and environmental assessment).
- 3. The introduction of controls over vegetated areas identified for future development in the townsite.

4. The introduction of controls over development of flood prone land and the protection of riparian vegetation in areas affected by the main drainage lines which traverse the townsite.

Popanyinning:

1. Modest residential development in the current undeveloped portion of the existing townsite.

Yornaning:

- 1. A rural industry precinct adjacent to the highway at Yornaning with supporting industry located in the former Yornaning townsite.
- 2. A Special Control Area over Yornaning townsite to control the possible mix of residential and industrial type uses.

The above proposals will allow the population of the Cuballing and Popanyinning townsites to increase to approximately 800 and 250, respectively, and allow for the future development of an agricultural industry precinct at Yornaning if demand requires.

The Town Planning Consultant has prepared an amended document incorporating the schedule of modifications as detailed by the WAPC. A copy of the document has been circulated with the Council Meeting Agenda.

When Council endorsed the addendums in April 2007 it was necessary for Councillors Brown, Newman and Wittwer to declare a financial interest as the proposed addendums affected properties in which they have an interest. However in this situation the decision before Council is to advertise the amendments for public comment, which is a different situation and does not require the Councillors declaring an interest.

Background

In September 2007, Council considered a request from the State Land Services (SLS) to comment on a proposal they had received from the Department of Environment and Conservation (DEC) to change the purpose of Reserve 36413 Neamutin Road from "Trigonometrical Station" to "Conservation of Flora and Fauna".

The referral to Council came following a proposal the DEC put to SLS to change the purpose of the reserve to enable the uncleared vegetation to become an important link in a "super" nature reserve, with neighbouring private owned areas and the Tutanning Nature Reserve, to preserve native flora and fauna within the region.

The major consideration for Council in this proposal was that the reserve is the host site for the Emergency Services Two Way Radio Repeater Station for the Shires of Cuballing and Pingelly.

At the September 2007 meeting, Council resolved as follows:

That Council supports the change in purpose for Reserve 36413 (Lot 151) Neamutin Road from "Trigonometrical Station" to "Conservation of Flora and Fauna" on the proviso that access to the Shires of Cuballing and Pingelly Emergency Services Two Way Radio Repeater Station is maintained and available at all times.

Correspondence has now been received from the DEC advising that the owners of Lots 285 and 347 Cooke Road, J & J English, have agreed to sell portion of the two lots that adjoins Reserve 36413.

The DEC are seeking comment from Council on the proposal to purchase portion of the two lots and merging into Reserve 36413. The land transaction will require a formal planning application to be submitted to the WA Planning Application, and they would like some comment/feedback from Council prior to commencing this process.

Comment

From the information, including aerial photographs, provided it appears that the portions of Lots 285 and 347 being referred to is mostly non arable land that has native vegetation coverage.

It appears that the proposal is quite acceptable and would only serve to enhance the nature corridor that the DEC is attempting to develop, without reducing the arable farming land available within the district.

CHIEF EXECUTIVE OFFICERS RECOMMENDATION

That the Department of Environment and Conservation be advised that Council supports the proposal for portion of Lots 285 and 347 to be subdivided out of existing titles and merged with Reserve 36413.
