Background

As reported to the December 2009 Ordinary Meeting of Council, on 11 December 2009, the Shire of Cuballing received a letter from the Minister for Local Government advising that he considers that the optimal reform option for the Shire of Cuballing is to engage with neighbouring local governments to form a Regional Transition Group. Help to form such a Group will be available from the Department of Local Government.

A Regional Transition Group will provide the structure for transitioning several local governments into a single entity by 2013 and is to be established under a formal agreement between the Department of Local Government and participating local governments and will facilitate the harmonisation of core functions and services across participating local governments. This process is intended to provide a seamless transition to a new entity and a new start while allowing for the staging of key elements of structural reform.

The core functions and services include, but are not restricted to:

- Strategic and community planning;
- Infrastructure planning and asset management;
- Economic development;
- Corporate services (IT, HR, records, finance, rating and other administrative functions);
- Planning and management of natural resources;
- Building and approval processes;
- Statutory and strategic land use planning;
- Environmental health; and
- Waste management.

The work of the Local Government Reform Steering Committee and the Department of Local Government is continuing and the Minister is to further consider matters relating to boundary change and elected member representation.

The Shire of Cuballing's overall position stated in its submission (29 September 2009) that if amalgamation is the only form of structural reform acceptable to the State Government, the Shire of Cuballing's preferred option is to amalgamate with the Shires of Narrogin & Wickepin and the Town of Narrogin, subject to certain key principles and conditions being agreed upon. This grouping of Councils forms the Regional Transition Group in which the Shire of Cuballing has been identified.

In respect to this matter, at the December 2009 Meeting Council resolved as follows:

That the correspondence from the Minister advising that the Shire of Cuballing's optimal reform option is to engage with neighbouring local governments to form a Regional Transition Group lay on the table until the February Ordinary Council meeting to allow Councillors time to consider the ramifications and also to receive further advice from the Department of Local Government regarding the costs involved of the proposal.

Comment:

Since the December 2009 Meeting the Local Government Reform issue has been heavily debated throughout the local government sector. As a result of this the WA Local Government Association held a Local Government Forum at the Ascot Racecourse on Tuesday 9 February 2010. The speakers at the forum included Hon John Castrilli MLA, Minister for Local Government, Mr Paul Papalia MLA, Opposition Spokesperson, Hon Brendon Grylls MLA, Minister for Regional Development and Hon Robin Chapple MLC, Greens Representative. The Forum was attended by the Shire President, Deputy President and Chief Executive Officer.

The Minister for Local Government's address continued down the path that the reform process is voluntary and if Councils wanted to embrace the process they would receive assistance, both financial and other, from the State Government, and those Councils that do not wish to amalgamate can choose to do so, however he believes that taking this action will be detriment to their communities and they risk losing future grant funding as both the State and Federal Governments will be keen to provide funding for regional and strategic projects in larger communities. The Minister also answered several predetermined questions and took questions from the floor.

Mr Papalia reiterated that the Labor Party does not support forced amalgamations of local governments. Brendon Grylls spent most of his time addressing the Royalties for Regions Country Local Government Fund however did conclude by stating that the National Party also does not support forced amalgamations. Robin Chapple concurred with the opposition to forced amalgamations.

The Shire President and Chief Executive Officer also attended a Regional Transition Group (RTG) Discussion at the Town of Narrogin on Thursday 11

February 2010. The discussion was conducted by officers from the Department of Local Government and was also attended by the Mayor/Presidents and Chief Executive Officers from the Shires of Narrogin & Wickepin and the Town of Narrogin.

The purpose of this discussion/meeting was for the departmental officers to provide an overview of the Regional Transition Group process.

Following this meeting a brief discussion was held between the representatives of the four local governments. Whilst all genuinely agree that the reform process is somewhat confusing and has been handled very poorly, they also feel it may be worthwhile entering into further discussions to consider the option of the RTG. Through the RTG process the preparation of a Regional Business Plan may help to determine (perhaps once and for all) if local government amalgamation is a serious course of action and also help the Councils be part of the decision making process and have some control of what happens to their respective local government areas.

The Minister has requested that he be advised by 26 March 2010 in respect to Councils willingness to participate in the RTG.

It is being proposed that the Shire of Cuballing considers undertaking further discussions with the Shires of Narrogin & Wickepin and the Town of Narrogin in respect to the RTG process, with final decision on the matter to be referred to the March 2010 meeting of Council.

GRADING/GENERAL MAINTENANCE

Summer grading maintenance is proceeding throughout the Shire. A grader has also been working on weekends to ensure the road network is maintained to a suitable standard.

Ron Panting from the Department of Corrective Services, Community and Juvenile Justice, has been assisting Council with various light maintenance duties over the past six months. Ron and his crew have assisted with clean ups in Popanyinning, Yornaning Dam, Cuballing Recreation Grounds, and the Dryandra Regional Equestrian Park.

REGIONAL AND LOCAL COMMUNITY INFRASTRUCTURE PROGRAM, ROYALTIES FOR REGIONS AND MAJOR PROJECTS

The Recreation Vehicle Area, Yornaning Water Harvest, Popanyinning Fire Shed, and Cuballing Cricket Practice projects have all been completed.

The Mens Shed is nearing completion, waiting on the arrival of lockers.

Works are continuing at the Dryandra Regional Equestrian Park. The equestrian clubs are busy relocating equipment to Cuballing in readiness for the first rally to be held on Sunday 21 February 2010.

Popanyinning Tennis Courts project is almost completed with just minor earthworks to be carried out to tidy up the perimeter of the courts.

Works are in progress erecting the portico on the northern side of the Popanyinning Community Hall.

2009/2010 ROAD CONSTRUCTION PROGRAM

Tender has been let for the reseal and final seal works included on the 2009/2010 capital works program. These works should be completed prior to end of March 2010.

Works on the Popanyinning West Road will commence within the next fortnight.

Background

Further to deputation by Mr John Francis, Mrs Val Francis & Mr Neil Francis to Council Meeting in December 2009.

Mr John Francis visited the Chief Executive Officer (CEO) at the Shire Administration Office in early 2006 and advised of possible intention of selling Lots 4167 & 3267. He advised that the lots were land locked however there is an unmade gazetted road reserve off Francis Road that could service the lots from the west with an easement placed over neighbouring Lot 4053, and/or an unmade gazetted road reserve that could service the land off Popanyinning East Road to the east. The CEO advised Mr Francis that the Shire is under no obligation to construct the unmade road reserve. As they (the property owners) are intending to sell the properties they could construct the road to suitable standards as required by Council. Mr Francis was not happy with the information provided by the CEO and commented on paying rates over a 50+ period of time and that it is should be the Shires responsibility and departed the building.

Mr Francis proceeded with the sale of the properties without further consultation with Council or staff. The property was sold to G & S Jones with an Annexure "A" to the property sale providing for the Sellers to provide an easement being legal access (reasonable road carriageway) from location 4053 fence line to be connected to location 4167 access to be a minimum of ten metres and to be put into place within 90 days acceptance of the offer, if settlement occurs before the easement is in place, the Sellers will grant uninterrupted access through location 4053 until this easement is completed. All cost of this easement is at Sellers cost. The document was signed on 27 April 2006. The easement documentation was lodged with State Land Services on 30 January 2008 and approved on 20 February 2008. Some months after the settlement date.

Email letter from Mr Peter Godridge (who purchased the property from Mr & Mrs Jones in October 2009) dated 1 December 2009 indicates that due to sheer frustration at the lack of suitable access to the property he has installed fencing along the easement and upgraded the road access at his own expense. Whilst Mr Godridge was considering the land purchase the CEO and Works Manager met with him on site on Saturday 13 June 2009, at 10:30am, Mr Neil Francis also attended this meeting of his own volition although was later in arriving. It was pointed out to Mr Godridge at this meeting that the Shire is under no obligation to construct the road and it should have been a condition of sale on the previous land transaction. Mr Godridge understood Council position on the matter.

In response to a telephone call from Mrs Jones on 1 October 2009, the CEO forwarded them a letter advising of Councils position and providing an estimate of what it could be to construct the road to the required standard. The letter also explained that the costs are estimates only and any works would have to be properly assessed.

At the Council meeting in December 2009 Mr Francis advised they had received a letter from the Department of Regional Development & Lands (DRDL) stating that it is the Shires responsibility to construct the road. The CEO has followed this up with the Manager – Wheatbelt Region of DRDL whom has provided a letter to Council to the contrary, also subsequent legal advice from McLeods Barristers and Solicitors supporting this.

The final comments in the letter from the DRDL states:

"There are many thousands of public roads in the State that are not currently constructed roads and may never have been constructed road of any kind! If a particular landowner adjacent to one of these unmade roads was desirous of obtaining practical access to the property, it would generally be a matter of either waiting for the Shire to prioritise the construction of that particular unmade road or constructing it at the owners expense at an earlier time."

The Solicitors letter in conclusion states:

"In my view, for the reasons set out –

- (a) The Shire has no legal obligation to construct a road on a road reserve;
- (b) Whether and, if so, when a road is or might be constructed on a road reserve are matters within the discretion of the Shire; and
- (c) It would be open to any person to construct a road, or fund the construction of a road, on a road reserve in the Shire's district but this would need to be done with the Shire's prior agreement and in accordance with the Shire's requirements."

Comment

Both of the DRDL and Solicitors letters confirm that the Shire is under no obligation to construct the road even though it is a gazetted road reserve.

It appears that the matter is really between the private parties and is something that the original vendors should have brought to the attention of the real estate agent and potential purchasers and should have been sorted out during the original sale of the properties.

Perhaps it would be beneficial for Council to consider adopting a firm policy to avoid a similar situation occurring in the future. The CEO will investigate this matter with neighbouring local governments.

CHIEF EXECUTIVE OFFICERS RECOMMENDATION

That Council advise all parties concerned; Mr S J Francis, Mr G & Mrs S Jones, and Mr P Godridge, of the advice received from the Department of Regional Development & Lands, and McLeods Barristers & Solicitors, and request they reach a private agreement as such for suitable construction of the road to the requirements of the Shire of Cuballing.

- Adequate dust suppression control methods and practices being used.

Background

Council has received an application for Planning Consent from Mr Pasquale Merolla for an extension of an existing zincalume shed (outbuilding) which will give a total area of 143m2 on Lot 128 Bunmulling Road, Popanyinning. The property is 71,800m2 in area and the shed extension would make the total area of the outbuilding 58m2 over what is required under the Shire of Cuballing Town Planning Scheme No 2 (Local Planning Policy Outbuildings).

Mr. Merolla has indicated that the extension to the outbuilding is to be used as extra covered workspace during the winter months and for storage.

Comment

The subject land is zoned Rural Residential under the Shire of Cuballing's Town Planning Scheme No.2 (Local Planning Policy - Outbuildings).

Oversized Outbuilding

Council's Town Planning Scheme No. 2 Policy (Local Planning Policy Outbuildings) states that in a Rural Townsite and Rural Residential zones of the Shire where the lot size is over 1500m2.

- (b) (i) Zincalume construction, where the total outbuilding does not exceed 85m2 in total floor area;
 - (f) Any application for planning approval, which does not comply with the above, shall be referred to Council for consideration.

The structure will be built onto an existing shed partially hidden from Bunmulling Road by trees and located to the side of an existing house on the 71,800m2 property. The property is used as a commercial olive farm and the extension to the outbuilding will be used for processing of olives. In regard to health related matters, the extension of the outbuilding would provide much needed under cover space for olive processing operations which will improve food hygiene. The existing use of the property is classified as 'non-conforming'. However, under the Town Planning Scheme it is classified as "A" giving Council its discretionary power to approve its use as an olive farm if it had not already been operating as such. The proposed 42m2 outbuilding extension will not interfere with the amenity of the area.
