IDENTITY FRAUD

A replacement driver's licence card or learner's permit will be issued free of charge if you have been a victim of identity fraud involving the use of your driver's licence or learner's permit details. You must provide one form of supporting evidence as listed below:

- Identity Crime Certificate issued by a State or Commonwealth court (if applicable); or

LOG BOOK

A replacement Learner Log Book must be applied for in person at DVS centres, regional DTMI offices or DVS agents. A fee applies.

Payment for a replacement driver's licence or learner's permit must be enclosed or the credit card authorisation completed, unless you provide evidence the card was stolen in WA or you have been a victim of identity fraud (see below for further details).

A replacement driver's licence card will be issued free of charge if the licence card was stolen in WA and a WA Police Force incident report number is provided overleaf. Not applicable to learner's permits or log books.

IDENTITY FRAUD
