to any Driver and Vehicle Services (DVS) centre or regional Department of Transport and Major Infrastructure (DTMI) office or agent within 14 days of the sale of the plates.

The purchaser must submit:

- the completed duplicate copy of this form; and
- the applicable plate transfer fee

to any DVS centre, regional DTMI office or agent.

If the purchaser wishes to immediately place the optional plates on a WA licensed vehicle, they must also submit the vehicle licence papers and the existing plates.

*No requirement where the optional plates are attached to a licensed vehicle that has been sold. The seller and purchaser must complete a Notification of Change of Ownership (MR9) form to transfer both vehicle and optional plates by ticking yes to transferring the right to display entitlement.

The holder of a 'Certificate of Right to Display and Trade' may offer that right for sale.

A sale can take place at any price to any individual or corporation by transferring the rights.

Optional Series plates can also be transferred to a new owner as part of the transfer of a vehicle licence when completing the MR9 form by ticking yes to transferring the right to display entitlement.

If the seller wants to retain ownership of the Optional Plates when the vehicle is sold, they must attend a DVS centre, regional DTMI office or agent with the Optional Plates and the current vehicle licence papers. The Optional Plates can be retained and changed for general issue State or District plates. The vehicle can then be sold with the general issue plates.

Deceased Estates

If you are the beneficiary of a deceased estate who will be receiving the plates as part of a Trust created in a Will, or Family Court Order you will pay a reduced plate transfer fee (please refer to the current schedule of Plate fees). You must present a copy of the Will or the Court Order at a DVS centre, regional DTMI office or agent.

The Will may specifically create a trust, but another way in which a trust is created is when a Will provides for a part of the deceased estate to go to a beneficiary at some future time. Confirmation of whether a trust is created can be made by sighting the Will. For example, a person has a right to display special or name plates, and their Will states for it to go to their child when they reach 18 years of age. If the person passes away before the child is 18, the right to display the special or name plates is held in the trust by the trustee/executor/administrator until the child turns 18. The right to display the special or name plates can then be transferred into their name for the reduced fee.

OUTSTANDING TRANSFER FEES FOR OPTIONAL SERIES PLATES

If you have outstanding plate transfer fees, you will be contacted by mail and advised of the requirement to pay those fees.

The CEO of DTMI can also demand the return of the number plates if the plates are not transferred. A penalty will apply if the plates are not returned.
