## DEFINITIONS

**Dutiable Value** - The term "dutiable value" is defined by Division 5 of the *Duties Act 2008*.

In relation to used vehicles - the amount for which the vehicle might reasonably be sold, free of encumbrance, in the open market. Where the dutiable value or purchase price of a vehicle has been incorrectly stated the matter will be referred to the Office of State Revenue for investigation and possible prosecution.
