Mr George Baylis sought an explanation from Council in relation to recent correspondence for the future subdivision of his property within the Cuballing Townsite.

The Shire President and Chief Executive Officer explained that applications for subdivision are lodged with the Western Australian Planning Commission (WAPC) and that agency makes the deliberation on the application. The Shire of Cuballing would be consulted on the application, as would a number of key State Government agencies, however the final decision is made by the WAPC.

The Shire of Cuballing Town Planning Scheme No 2 does not categorically state that subdivision of land within the Rural Residential

areas of the townsite cannot be approved, however Council has recently prepared an addendum to its Local Planning Strategy and this is currently before the WA Planning Commission (WAPC) for approval. The addendum has identified areas for future subdivision within the townsite and Mr Baylis' property is not within the identified area and as such Council is unlikely to support an application for subdivision for the property.

Mr Baylis further sought information pertaining to recent road works on Beeston Street, Cuballing.

The Chief Executive Officer explained that the road was supposed to have been resealed in 2007/2008 Financial Year to complete the works, however due to delay in contractors arriving on site and early break to the 2007 winter the works could not be completed. It is anticipated that the reseal works will be carried out within the next two months.

All of the tenders indicate the aggregate type to be used will be 10mm granite.

RNR have indicated the proposed application rate to be 1.80, whereas Boral have indicated that this is to be confirmed as they will assess the conditions on the day of work. Generally the application rates can vary on the day of reseal depending upon the road surface texture, weather conditions and road surface temperature, however this will not have an affect on the tendered prices.

Boral have submitted an alternate tender which is 24 cents per square metre cheaper that their tender which conforms with the tender specifications. In the conforming tender they have locked in amount of \$3.75 as a fixed price contract as they are prepared to take the risk of the rise and fall of bitumen prices over the duration of the works program With the alternate tender the price, as shown in the tender, is based on the current bitumen price however would be subject to the rise and fall price over the duration of the works and this is a risk that Council would then have to take, for example the price may start out at \$3.51 (currently) but could fluctuate to \$4.00 (or higher) by the end of the works and Council would then have to pay that price at that time. Given the current world economic climate it is not being proposed that Council accepts the alternate tender.

All tenders are within budget parameters for 2008/2009, however the conforming tender submitted by Boral when compared to RNR does allow for some additional flexibility within the budget allocation.

Water Samples

Samples of Water were taken at the Dryandra Village and forwarded to PathWest (State Water Examination Laboratory) for analysis. The test results have indicated that there are no problems with the on site water sources.

Noise Complaint

A Sound Monitoring Meter was recently placed at complainants residence in Popanyinning in relation to noise complaint for the Popanyinning Kennels.

The monitor was in place for 14 days, from 19 September to 2 October 2008, and has now been returned to the Department of Environment and Conservation for assessment. To date no further information has been received.

Building Licence 12-2006/2007, Lot 105 Alexander Street, Popanyinning

A Building Licence was issued to the owner of Lot 105 Alexander Street, Popanyinning, Mr Robert Stonehill, on 31 August 2006, to build a relocatable house on the property. Inspection of the property on 19 September 2008 revealed that the dwelling has not been completed or even substantially commenced. A letter was forwarded to Mr Stonehill on 22 September 2008 (copy included in agenda document), requesting he contact Council's Environmental Health Officer/Building Surveyor within 14 days to advise of his intentions. To date no contact has been received from Mr Stonehill.

The Local Government (Miscellaneous Provisions) Act 1960, Part XV – Buildings, Division 12 – Neglected, Dilapidated & Uncompleted Buildings, Section 409A Uncompleted Buildings, states as follows:

409A Uncompleted Buildings

- (1) Where the erection of a building has been commenced but not completed within the time prescribed by the local laws, if any, made under section 433(39), that are applicable to the building, the local government may, by notice served on the owner of the building, require him to show cause, within 60 days of the service of the notice, why the building should not be demolished or removed.
- (2) Where an owner on whom a notice has been served pursuant to subsection (1) fails, within 60 days of the service of the notice, or within such further time as the local government allows for the purpose, to satisfy the local government that there are good and sufficient reasons for the failure to complete the erection of the building within the time referred to in subsection (1), the local government may-
 - (a) by order served on the owner require him to have the building demolished and removed within such reasonable time as the local government specifies in the order; and
 - subject to subsection (3), where the owner fails to comply with the terms of the order referred to in paragraph (a), demolish and remove the building, and recover the costs incurred on account of the demolition and removal as a debt due to it.
- (3) An owner on whom an order is served pursuant to subsection (2)(a) may, within 15 days of the service upon him of the order, apply to the State Administrative Tribunal for a review of the order.
