Sally Haslam painted a large picture of the hotel, this was signed by all attendees and now hangs proudly in the Popanyinning Hall.

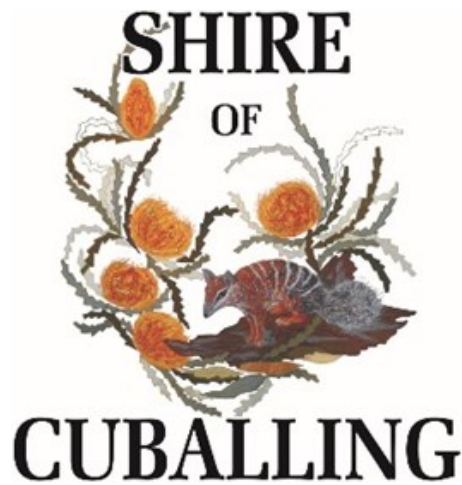

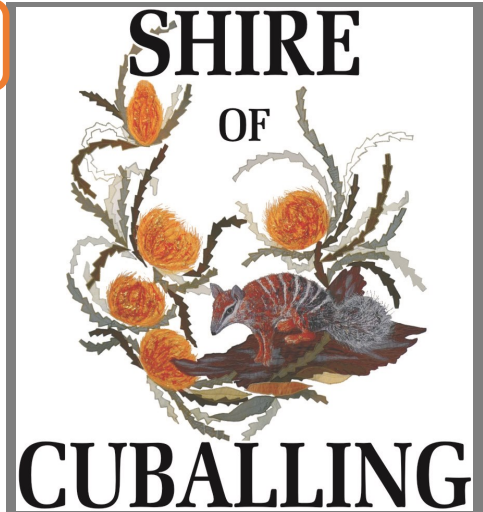

PRESIDENT'S PEN

The State Government has proposed changes to the Dog Act for WA and have released a consultation paper prior to the final drafting of the legislation.

The impact on dog owners and breeders seems to be onerous. I am concerned this proposal while attempting to eliminate puppy farming, shifts the financial and compliance burden to the average owner of domestic and/or working dogs.

The main elements of the changes and associated impact is summarised below:

Pet shop owners will not be able to sell puppies. Any pet shop dog sales must come from registered dog rescue organisations or shelters

PET SHOPS	Pet shops will only be able to source dogs from accredited dog rescue organisations and shelters after a specified date. Pet shops will need to ensure that each dog has a health and behavioural certificate supplied by a veterinarian.
POTENTIAL AND CURRENT DOG OWNERS	People looking to purchase a dog can still buy a dog from a pet shop, but the dog will be sourced from an accredited dog rescue organisation or shelter and assessed for behaviour and health. Owners will not be able to give unwanted dogs or puppies to pet shops.
DOG RESCUE ORGANISATIONS AND SHELTERS	Dog rescue organisations and shelters will be invited to apply for accreditation as potential suppliers of dogs to pet shops in Western Australia. Every dog to be supplied must pass a health and behavioural assessment undertaken by a veterinarian.
DOG BREEDERS	Dog breeders will not be able to supply pet shops.
STATE GOVERNMENT	The State Government will need to put an accreditation framework in place for dog shelters and rescues.
ENFORCEMENT AGENCY	The enforcement agency will need to monitor pet shops to ensure they are only sourcing dogs from accredited dog rescue organisations and shelters.

All dogs not registered as a breeding dog will need to de-sexed

PRESIDENT'S PEN

DOG OWNERS	<p>All dog owners will either have to have their dog de-sexed or apply for an exemption.</p> <p>All dogs will be required to be de-sexed by the time they reach a particular age. Dog owners must provide proof of de-sexing to their local government.</p>
DOG BREEDERS (includes any person whose dog has puppies)	<p>Dog breeders will need to register as a dog breeder on the centralised registration system in order to exempt their dog/s from being de-sexed.</p>
LOCAL GOVERNMENTS	<p>Local Governments will continue to be responsible for enforcing the Dog Act, including approving dog registration applications, checking a dogs de-sexed status (as evidenced by a veterinary certificate) and updating the de-sexed details of a dog's registration.</p> <p>Local governments will be able to refuse to register a dog on the grounds the dog is not de-sexed (unless it is otherwise exempt).</p>
VETERINARIANS	<p>A veterinarian carrying out a de-sexing procedure on a dog, will be required to provide a certificate to the dog's owner confirming the dog is de-sexed.</p> <p>Where a veterinarian assesses a dog as being exempt from dog de-sexing on health and welfare grounds, they will be required to provide an exemption certificate to the dog owner.</p>

PUBLIC	<p>Members of the public will be able to use the system to verify whether a dog owner is a registered dog breeder.</p> <p>Members of the public will be able to report advertisements for dogs or puppies that do not contain the required information.</p>
DOG MANAGEMENT FACILITIES AND DOG RESCUE ORGANISATIONS AND SHELTERS	<p>Facilities will be able to register dogs in their ownership and care online. Facilities will have online accessibility to search and update the details of dogs in their care.</p> <p>Facilities that receive abandoned or surrendered dogs will be issued with a "dog owner number" to be recorded alongside the dog's microchip details where the breeder is unknown. MICROCHIP COMPANIES	<p>Microchip companies will be required to record the dog owner number alongside a dog's microchip details on the microchip database for all dogs born after a particular date and to retain this information.</p> <p>This may require the addition of another field(s) in the microchip database.</p>

A central register of dogs, dog owners and dog breeders will be established, and costs passed on in registration fees.

PUBLIC	<p>Members of the public will be able to use the system to verify whether a dog owner is a registered dog breeder.</p> <p>Members of the public will be able to report advertisements for dogs or puppies that do not contain the required information.</p>
DOG MANAGEMENT FACILITIES AND DOG RESCUE ORGANISATIONS AND SHELTERS	<p>Facilities will be able to register dogs in their ownership and care online.</p> <p>Facilities will have online accessibility to search and update the details of dogs in their care.</p> <p>Facilities that receive abandoned or surrendered dogs will be issued with a “dog owner number” to be recorded alongside the dog’s microchip details where the breeder is unknown. The number will assist in tracking the dog.</p>
MICROCHIP IMPLNTERS	<p>Microchip implanters will be required to provide the dog owner number of the dog’s mother, and father if known, to the microchip company.</p>
MICROCHIP COMPANIES	<p>Microchip companies will be required to record the dog owner number alongside a dog’s microchip details on the microchip database for all dogs born after a particular date and to retain this information.</p> <p>This may require the addition of another field(s) in the microchip database.</p>
LOCAL GOVERNMENTS	<p>Local governments will no longer be required to maintain and resource their own dog registration record system.</p> <p>Local governments will process and approve dog registrations and dog breeder registrations online.</p> <p>Local governments will be responsible for issuing registered dog breeders with a certificate which contains their unique “dog owner number”.</p> <p>Local governments will be able to identify dogs from all local government districts.</p> <p>Local governments will be responsible for enforcing the following :</p> <p>Dog breeder registration</p> <p>Recording the dog owner number on the dog’s microchip database when provided with the information.</p>
ENFORCEMENT AGENCY	<p>An enforcement agency will be responsible for enforcing the requirement for dog owner to provide certain information when advertising or transferring a dog.</p>
STATE GOVERNMENT	<p>The State Government will be responsible for developing and maintaining the centralised registration system.</p>

DOG OWNERS	<p>Dog owners will be able to complete their dog registration online. Each dog owner will be issued with a unique “dog owner number”. Dog owners will be required to provide their unique “dog owner number” and the dog’s microchip number when advertising, transferring, selling or giving away their dog.</p> <p>Dog owners will pay higher dog registration fees than what they are currently paying.</p>
DOG BREEDERS	<p>Dog breeder must register as a dog breeder on the centralised registration system.</p> <p>Dog breeders must record their “dog owner number” on the microchip database for any puppy that is bred from their dog.</p> <p>Dog breeders will be required to provide their unique “dog owner number” and the dog’s microchip number when advertising, transferring, selling or giving away a dog.</p> <p>Registered dog breeders will be searchable on the centralised registration system.</p> <p>Dog breeders may be required to pay an annual fee to register as a dog breeder.</p>

There will be mandatory standards for dog breeding, housing, husbandry, transport and sale.

DOG OWNERS	<p>Under proposed WA Standards and Guidelines for the Health and Welfare of Dogs (once developed), all dog owners will need to comply with minimum standards for housing, husbandry, transport and sale to ensure the health and welfare of their dog.</p>
DOG OWNERS THAT WISH TO BREED A DOG OR DOGS	<p>Under the Dog Breeder registration proposal, dog breeders will be required to register as a dog breeder on the centralised registration system.</p> <p>Registered dog breeders will need to comply with the Mandatory Standards for Dog Breeding and give regulatory authorities reasonable access to their premises to check compliance with the Standards.</p> <p>It is proposed that commercial dog breeding establishments will need to comply with additional standards.</p>
VETERINARIANS	<p>New requirements for veterinary health checks of breeding dogs are proposed.</p>

Enid Cavanagh and her dolls

Enid Cavanagh a lifetime resident of Narrogin and Cuballing, widely known for her large collection of dolls, has now achieved her dream of ensuring her collection be a contribution to the community for charitable purposes. Enid's doll collection became a community effort as people gave her old dolls, and Enid lovingly redressed them, using fabric donated to her, including early 1900's wedding and christening dresses. Enid an accomplished dressmaker also repainted, restrung and repaired dolls.

The Art Group now have display cabinets of Enid's dolls, some of which she made from porcelain blank faces models which she china painted at Art Group, then made soft bodies and clothed. All three primary schools in Narrogin have accepted a collection of Enid's dolls for fund raising and kindergarten play. Narrogin Primary School also has Enid's international dolls on display with children needing to guess where the national costumes come from. The money from the sale of Enid's valuable and antique dolls has been donated to charity by her daughters.



► One of the popular displays at the recent Narrogin Nursing Home open day was the doll collection of Enid Cavanagh (pictured above). Mrs Cavanagh started collecting dolls over 30 years ago and now her collection includes 700 dolls and takes up a whole room in her home. "I just love dolls and showing them to different people", she said. The Narrogin Nursing Home's open day was well supported with monies raised from the various produce, bric a brac and plant stalls going towards providing extra comforts for residents.

CUBALLING WAR MEMORIAL *by Stephen Bowes*

Arthur Hancock, Trooper 828 (10th Light Horse Regiment)

The hard cold stone of Cuballing's War Memorial records the name A Hancock as a soldier who did not survive his service to his country in the Great War. Curiosity leads us to question: who was this man? What was his life like? How and where did he die?

The Commonwealth War Graves Commission gives us a lead to follow, but the information is brief and hard. Arthur Hancock was killed in action on August 7, 1915 at Walkers Ridge, Gallipoli Peninsula. He lies buried in Point Cemetery, Ari Burnu, half a mile north of Anzac Cove. There is no mention of his parents, nor next of kin and no place of association.

We can be thankful that the service records held at the National Archives of Australia are more informative. Arthur Hancock was a native of Northampton, England, living in Western Australia. He had recently had his 35th birthday when he enlisted at Perth on January 6, 1915. This made him relatively senior, both in years and in prior military service, as he had served thirteen years and three months in the Northampton Regiment prior to coming to Australia. This seniority saw him promoted from trooper to sergeant after only ten days in Rockingham training camp.

"Intensive training was the order of the day at Rockingham, and of all the dusty, dirty camps and bivouacs experienced in the course of its varied career, Rockingham will be remembered in the Regiment as one of the dustiest and dirtiest. The one saving grace was the proximity of the sea, and the daily swim..."

The compulsory medical examination revealed a man of five feet seven inches with fresh complexion, brown hair and brown eyes. He had some distinguishing marks in the form of extensive tattoos: the Lord's Supper on his back, a lion on his stomach, an eagle in the centre of his chest and a snake around his neck. He belonged to the Church of England. Sergeant Hancock became Trooper 828 when he was appointed to the 3rd Reinforcements, 10th Light Horse Regiment. The 2nd and 3rd Reinforcements sailed from Fremantle aboard SS Itonus (designated as His Majesty's Australian Transport A50) on February 19, 1915.

The reinforcements spent time at Mena Camp in Egypt, before embarking at Alexandria for Gallipoli on the sixteenth of May. At the Dardanelles, as part of the August offensive, the 3rd Light Horse Brigade was tasked with providing a diversionary attack at Walkers Ridge in the dawn light of August 7. The New Zealanders were to have done the same at Chunuk Bair, whilst the British Force attacked from Suvla.

The narrow piece of ground over which the 8th and 10th Light Horse were to attack is known as The Nek. The Victorian Regiment went first and were mown down in No Mans Land.

"As one officer described it, "The air was thick with lead", and it was estimated that the fire of at least thirty machine guns was sweeping that thirty or forty yards of "No Mans Land" on the Nek. Nevertheless, the reply from the Brigade Major, Colonel Antill, was to the effect that the 10th Regiment would carry out their orders and attack.....Many glorious lives were thrown away, but no impression could be made on the enemy defences".

CUBALLING WAR MEMORIAL *by Stephen Bowes*

Quotations are taken from '10th Light Horse A.I.F. Westralian Cavalry in the War' by (Narrogin Dentist) Lieutenant-Colonel Olden.

We know that Arthur Hancock's wife was dead, and that he had two sons: the elder, Henry George and John Arthur, who lived at the Swan Boys Orphanage, Midland Junction. In 1921, Henry signed for receipt of his father's medals, memorial plaque and scroll and personal effects: spurs, postcards, papers, book, identity disc and an Indian Medal with three bars. Henry was twelve years old. Both boys were granted a pension of nineteen pounds and ten shillings per annum for the loss of their father at Gallipoli.
