## COUNCIL SHORTS

Dogs are considered to be man's (and woman's) best friend and, as a dog lover, it is easy to see why; they provide protection of their family and property, they are great company, they give unconditional love to their owners and even help us live longer. They are also one of the biggest sources of complaints to Council.

One of Council's obligations is to uphold the Dog Act and associated Regulations, and to do so we subcontract rangers from the Shire of Narrogin to undertake this work on the Shire's behalf.

As a dog owner, your responsibilities are to:

- Ensure your dog is microchipped and registered with the Shire;
- Keep your dog - whether by fencing or restraint on your property and leashed when out in public spaces - and not allow it to stray onto other people's properties;
- Ensure your dog is not causing a nuisance with loud, incessant barking; and
- Keep only two dogs if you live within the town boundaries.

People are entitled to make complaints about dogs to Council if they stray or cause a nuisance. These complaints are then forwarded onto the ranger who investigates and takes action where appropriate. All complaints are recorded by staff and are presented to council at our monthly meetings. *(N.B. Every complaint made to the shire from a pothole to a fallen tree to ants in the hall is given to Council and we are pleased to get them – it helps us ascertain how the Shire is going overall.)*

If the Shire does not receive a complaint, our shire workers and rangers have nothing to go on when it comes to taking action. If complaints are made through the shire office, our staff can then take action and we have record if a dog, cat or other animal is a repeat offender. If you are able to supply dates, times and photographic evidence that is a big help.

A recent dog attack resulted in a social media storm with numerous accusations and threats being made. In general keyboard warriors are not helpful in any way and, in this case, threats were made to Council staff which is totally out of order.

## Fact Sheet – Laws for Dog Owners

---

This document provides a summary of the legislation which applies to dogs and the dog owners.

### What does the Dog Act cover?

The Act addresses the registration of dogs, the keeping of dogs in the community and the legal obligations of dog owners.

The Act applies to all canines. This includes dingoes and dog/dingo crossbreeds.

### Who enforces the Act?

The Act is enforced by local governments within their respective districts.

If you are aggrieved by a local government's application of the Act, you may be entitled to have that decision reviewed in the State Administrative Tribunal.

### Why do these obligations apply?

Everyone who owns a dog has a responsibility to ensure that the dog is properly cared for. In addition, it is important that dog owners handle their animals in a way that respects other people in the community.

### Legal responsibilities for dog owners:

#### **Dog control - Penalty: \$200 to \$5000**

If you own a dog, you have a legal responsibility to keep the animal under control, either within a fenced area on your property or on a leash when in public.

Local governments can set out dog exercise areas where dogs can be taken off a lead without penalty. Please contact your local government for further details on the exercise areas in your district.

## **Barking dogs - Penalty: \$200 to \$5000**

While dogs are allowed to bark, they are not allowed to bark excessively in a way that causes a nuisance.

## **Dog droppings - Penalty: \$50 to \$5000**

Dog droppings are a source of annoyance to the users of footpaths and public recreation areas.

Most local governments have local laws in place that require a dog owner to remove their dog's droppings if the dog excretes in a public area. The penalty for failing to do this will vary between districts.

## **Dog attacks - Penalty: \$3000 to \$20,000**

A dog attack is a very serious matter. In addition to harming other animals, a violent dog can inflict serious injury on children or the elderly.

If your dog attacks a person or another animal, you can be held responsible even if you are not there at the time. If the dog causes serious injury to someone, you may even receive a jail sentence.

## **Dog registration - Penalty: \$200**

A dog owner is legally required to register the dog with the appropriate local government once the dog is 3 months or older.

To register your dog, contact your local government for a registration form and a list of applicable fees.

## **Registration tags - Penalty: \$200**

A registered dog is required to wear a collar with a valid registration tag. This tag will be issued by your local government when you pay your registration fee.

## **Microchipping - Penalty: \$200 to \$5000**

All dogs must be microchipped once they reach 3 months of age.

Non-microchipped dogs cannot be sold or transferred to a new owner. This rule applies even if the dog is under 3 months of age.

Dogs may be exempt from receiving a microchip if they cannot receive one due to medical grounds. In those situations, the owner will need to obtain a medical exemption certificate from a registered vet.



## Dangerous dogs

The Act has specific obligations which apply to:

- restricted breed dogs.
- commercial security dogs.
- dogs who have previously committed a dog attack.

In many cases, the penalty issued for an offence under the Act will be doubled if a dangerous dog is involved. Dangerous dogs also have specific requirements regarding collars, muzzling and general confinement.

The dangerous dog fact sheets on the department's website set out this information in further detail.

## Dog Local Laws

Each local government can introduce local laws on a range of matters, including the number of dogs which can be kept on the premises.

For further information on your local laws, please contact your local government.

If you wish to inspect your district's dog local law, a copy can be freely accessed on the department's local law register.

## Review of decisions

Dog owners have a right to seek a review of certain decisions made under the Act, if the owner believes the decision was incorrect.

These decisions can be internally reviewed by the local government or they can be appealed in the State Administrative Tribunal.

This right of appeal applies to:

- a decision on whether excess dogs may be kept on the premises.
- a local government's refusal to register your dog.
- an order declaring that your dog is dangerous.
- the seizure of your dog.
- a dog destruction order.

If you wish to have one of these decisions reviewed, you should notify the local government as soon as possible and consider obtaining legal advice.

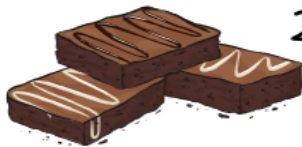

Hotham-Williams sub-catchment update

## PHCC Launches 2025–2027 State NRM Community Stewardship Grant: Resilient Farms, Nature & Communities

PHCC is excited to announce the launch of its 2025–2027 State NRM Community Stewardship Grant, Resilient Farms, Nature & Communities. This initiative aims to support landholders in building more resilient and sustainable farming systems by enhancing skills, strengthening capacity, and promoting the sustainable management of land resources tailored to local needs. The project also focuses on conserving and restoring biodiversity through a range of on-ground actions.

Activities will include fencing, revegetation, event facilitation, invasive species management, and the development of best-practice methodologies to guide sustainable land management.

This project will be delivered across the Hotham-Williams sub catchment and the Swan Coastal Plain within the PHCC region. In these areas eligible farmers will have access to a fencing subsidy, seedlings to boost farm ecosystem health and enhance permanent vegetation cover as well as targeted weed control programs with a focus on spiny rush (*Juncus actutus*). In collaboration with local groups in PHCC's upper catchment (the Hotham-Williams) the project will also continue targeted feral pig control efforts. Additionally, PHCC will consult with specialists to review and update existing restoration guidelines for degraded and saline land with a focus on the Hotham-Williams sub catchment.

There will be a variety of events open to the community over the 3-year period that will increase landowners opportunities to learn about sustainable growing systems, increasing biodiversity and ecosystem function along with maintaining or improving productivity.

Partner organisations for these events include Birdlife Australia, Peel-Harvey Biosecurity Group, SJ Food and Farm Alliance and RegenWA.

## River Warriors

PHCC has been hanging out on the Williams River with the local Wildlife Warriors for 4 years, and credit goes to the Williams CRC, who organise the regular activities, and also the kids and parents who come along to learn about our natural environment.

The timing has been perfect to include them with the project on the Williams River, which has been backdrop to all of the Warrior sessions that PHCC has been involved with since 2021. When we were asked to do the same in March this year, the bank rehabilitation had just been completed, and the kids were able to have a walking tour of all the structures on the banks, around significant trees, and in the bed of the river.

While they were there, the warriors checked on the seedlings that they have helped to plant since 2022, and completed a hilariously high-speed and enthusiastic 'treasure' hunt of natural features.





# Landcare matters

Hotham-Williams sub-catchment update



## Exploration surveys for Carnaby and Baudins Black Cockatoos

PHCC and Birdlife Australia have been undertaking exploration surveys for Carnaby and Baudins Black Cockatoos around the Hotham-Williams area.

We traversed bushland areas around Wandering (Timber Reserve), Boddington, Dryandra, Dwellingup, Montague State Forests and Quindanning, searching for signs of recent Black Cockatoo foraging and breeding. Thank you to our volunteers who provided more eyes on the ground, but particularly to the Wilman Elders (Jock and Nick Abraham) who joined our Dryandra surveys and provided important historical information about bush tucker and the significance of Dryandra for Wilman People. Stay tuned as we collate our results following 15 days of intensive field surveys.

Following recent droughts and consecutive years with lower than average rainfall, there seems to be a shortage of good quality seed in most bushland sites. As a result, we observed fewer signs of foraging at bushland sites previously known to be important sites for Black Cockatoos, but found increased signs of foraging and roosting around farmland and pine plantations. These findings reinforce the importance of preserving all large

forage trees in the catchment and also supports a staged approach to clearing pine plantations.

## Field Day at Cuballing with Mulloon Institute

On Monday 31 March participants gathered at a farm in Cuballing for a Landscape Rehydration Field Day. The event included technical, theoretical, and practical in-field demonstrations exploring how water moves through a landscape.

Mulloon institute Landscape Planner and Hydrologist Lance Mudgway delivered a comprehensive explanation of the water cycle, highlighting the relationship between water, plants, solar radiation, and gravity. In the field, participants had the opportunity to assess the landscape, identify patterns and processes, and deepen their understanding of soil and water interactions. Key discussions focused on salinity, erosion, and how these challenges can be addressed through planning and design to achieve sustainable water conservation.

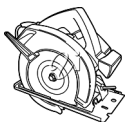
